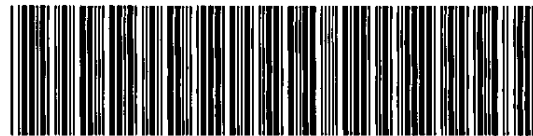

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not For Profit)

ARTICLE I NAME

The name of the corporation shall be:
