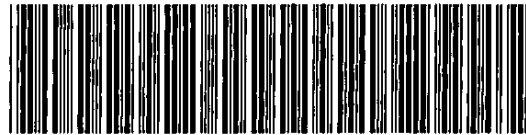


#### **ARTICLE XI Authority of the Corporation**
