# Article III - Purpose (Amended)

1. The objective and purpose of the organization shall be to provide a merit-based scholarship fund which will benefit Charlotte County individuals who desire to attend an accredited college, university or academy in the state of Florida for the purpose of pursuing a career in law enforcement.

2. Any other provision of these Articles, By Laws or any rule adopted by the directors to the contrary notwithstanding, no part of the earnings of this corporation or the assets hereof shall ever inure to the benefit of any individual, but shall be used only for the charitable purposes stated herein.

On termination of the existence of this organization, any remaining funds or assets shall be transferred by the directors to another organization qualified under the laws and regulations of the Internal Revenue Service to operate as a charitable organization with tax exempt status.

# Article VIIII Exemption under IRC Section 501(C) (3) (Added)

#### Section 1

Said organization is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to organization that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Section 2

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its directors, officers, or other organization members, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof, including to organization members who may meet the objectives stated in Article III. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other purposes not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under Section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### Section 3

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
