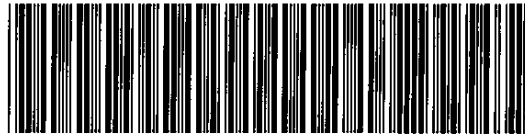

In Compliance with Chapter 617 F.S. (Not for Profit)**

ARTICLE I:
