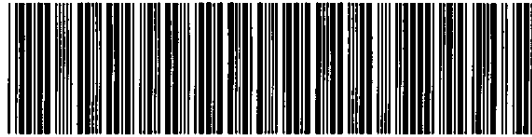

ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be the *Hardee Amateur Radio Group Inc.*

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 404 W. Orange Street, Communications Room, Wauchula, FL 33873-2831.

ARTICLE III PURPOSE

The purpose for which this corporation is organized is to promote and support the Hardee County Amateur Radio Emergency Services and its primary served agencies: Hardee County Emergency Management and Manatee County American Red Cross, Hardee County Branch. Also the *Hardee Amateur Radio Group Inc.* shall also in accordance with the objectives stated in Title 47 of the Code of Federal Regulations, Part 97.1, which govern the Amateur Radio Service, shall also advance skills in both the communications and technical phases of the art, and to continue to enhance international good will.
