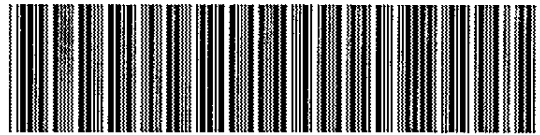

**Articles of Incorporation
Leartist Legacy Incorporation, INC.**

The undersigned incorporator of a non-profit corporation under Chapter 617 of the Florida Statutes does hereby adopt the following articles of incorporation for such corporation:

**Article I
Corporate Name**

The name of the corporation shall be: **Leartist Legacy Incorporation, INC.**

**Article II

Purpose, Powers and Duration of the Corporation**

This Corporation does not contemplate pecuniary gain of profit to the trustees thereof, This Corporation is name after my Mother name Leartist Hayes who's' time here on earth pass much too soon, she passed away in 1994 at the age of 49 years young. She gave all that she had to everyone around her she always wanted to be and opera singer but dedicates her life to family and friends.

- (a) Exercise all privileges of the Corporation, as the same maybe amended or supplemented from time to time, (The Goals). In particular, and not in Limitation,

the Corporation shall operate, maintain and manage the books, poetry, CD's DVD's, in manner consistent with Florida's non-profit Corporation and restrictions and covenants contained there in.

- (b) Assess, levy, and collect, and enforce payment by any lawful means of, all charges and assessments pursuant to the term of the law; and pay all expenses in connection there with, including expenses incidental to the conduct of the business of the Corporation, and also including all licenses, taxes, or governmental charges levied on or imposed against the Corporation as well as insurance maintained by the corporation;
- (c) Acquire, own, maintain, Convey, sell, lease, transfer, or otherwise dispose of real property and personal property in connection with the affairs of the Corporation;
- (d) Attain grants (money), and with the assent of Chief Executive Officer plus one trustee, deed in trust or hypothecate any or all of its real or personal property as security for money received, or debts incurred.
- (e) Dedicate sell or transfer all or any part of the Corporation to any public of the Corporation to any public agency authority or utility for such purposes and subject to such condition as maybe agreed to by the Chief Executive Officer. No such dedication, or transfer shall be effective unless and instrument has been signed by Chief Executive officer and one trustee, agreeing to such dedication, sale or transfer.
- (f) Participate in mergers and consolidations with other non-profit corporation organized for the same or similar purposes, provided that any such merger, consolidation or annexation have the assent of chief Executive Officer and one trustee (board member)
- (g) Have and to exercise any and all powers rights and privileges, which a corporation organized under the Non-Profit Corporation law of the State of Florida by law may now or here after have or exercise.
- (h) Assessment shall be used for maintenance and repair of the Vehicles, Gainful employment, management, and items acquire for the Corporation to perform it duties, but not limited to work within and help other Non-Profit Organizations.

Duration

Existence of the Corporation shall commence with the filing of These Articles of Incorporation with the Secretary of State, Tallahassee Florida. The Corporation shall exist in perpetuity.

Article IV

Manner of Election

The manner in which the directors are elected or appointed:

The Chief Executive Officer shall be a permanent part of the board.

Any one who is knowledgeable to the rules and regulation of a Non-Profit organization can be appointed or elected onto the board.

The affairs of this Corporation shall be manage by a Chief executive officer and Board of Directors not less than three(3) nor more than (7) Directors(trustees) who shall need not be members of the Corporation. The number of directors (trustees) may be changed by Chief executive officer in charge and one Director (trustee).

Each board member (director, trustee and CEO) is entitle to one vote.
At the annual meeting the CEO and the Directors (trustee) can elect three for a term of three years, two Directors for the term of two years and two Directors for the term of one year. The same Directors are allowed to stay on the Board as long as they are giving helpful input.
