

ONE: The name and address of this principal corporation is Lois Gilmore-Smith Ministries, Inc. 5710 North Miami Avenue Miami, Florida 33127, in Miami-Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for, Religious and Charitable purposes. To establish structured support service for Apostolic, Prophetic, and other Ministries for the Body of Jesus Christ (The Church). In accordance with the Doctrine of the corporation creed/bylaws to proclaim the gospel of Jesus Christ by equipping the Body of Christ for End Time Revival. The religious programs will consist of but shall not be limited to:, Spiritual Warfare & Deliverance Workshops, Mass Services, Conferences, Retreats, Publishing, Gift Shop, and other programs to aid those who are in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
