# ARTICLE I - NAME

ON, TNC. OF SIGN OF SI The name of the corporation shall be RACING BEYOND LIMITS ASSOCIATION

## ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 4574 Dyer Blvd., Suite 15-16, Riviera Beach, Florida 33407.

#### ARTICLE III - PURPOSE

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The corporation shall engage in recreational and educational therapy involving every aspect of racing, including driving, building, and maintaining racing vehicles. The primary beneficiary of the corporations endeavors will be disadvantaged and disabled persons without regard to sex, color, creed or national origin.

#### ARTICLE IV - INITIAL DIRECTORS

The names and addresses of the persons who are the initial directors of the corporation are as follows:

Directors shall be elected each year at the annual meeting. The top four persons receiving votes for director shall be the new board each year. Vacancies on the board shall be filled by the remaining directors.

### **ARTICLE V - FUNDS**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

#### ARTICLE VI - DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
