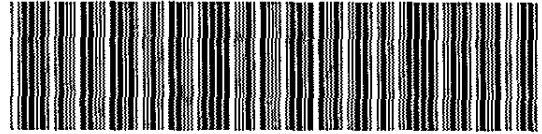



We the undersigned, pursuant to Chapter 617, Florida Statutes, hereby associate ourselves and our successors for the purpose of becoming a Corporation (Church) Not-for-profit under the laws of The State of Florida and do hereby adopt the following Articles of Incorporation.

### ARTICLE I NAME

The name of the Corporation (Church) shall be **SOUTHERN HEIGHTS CHURCH OF CHRIST, INC.**

### ARTICLE II PRINCIPAL PLACE OF BUSINESS

### ARTICLE III PURPOSE

The general objective and purpose of this Corporation (Church) shall be to build a Church devoted to God, dedicated to each other and determined to reach the world for Jesus Christ. Our mission is to glorify God by "Connecting people to God, each other and the world" through the fulfillment of the Great Commandment (Matthew 22:36-40) and the Great Commission (Matthew 28:18-20).

The goal of this Corporation (Church) is to be a Biblically functioning community of believers so that God's purposes can be accomplished in the world.

The Corporation is a charitable and religious not-for-profit Corporation (Church) organized and operated exclusively to carry on any and all activities and practices related to (Church of Christ) religious beliefs and to exclusively receive and administer funds for charitable and educational purposes within the meaning of 501 (c) (3) internal Revenue Service code of 1986 (as amended) or the corresponding provision of future United States internal revenue law, including for such purposes, the making of distributions to organizations which are recognized as exempt from tax under such 501(c) (3).
