

We the undersigned, desiring to incorporate filing under the Internal Revenue Service code 501-C (3), not for profit, in accordance with the laws of the State of Florida, do make and file these Articles of Incorporation, for the purpose constituting ourselves as a incorporation. The name of our incorporation is taken from the Withlacoochee River which flows thought Pasco County and flows to the Gulf of Mexico and has been the home of Native American People before and since 1814.

Article I

The name of this corporation, Not for Profit, shall be: Withlacoochee Native American Indian Culture, Incorporated.

Article II

Article III

Object and Purpose

The object and purpose of this corporation, not for profit, shall be to preserve, protect, maintain and practice the Native American Tribal Life. This will include the perpetuation of the tribal laws, rights, cultural traditions and religious practices thereof and to provide for a place of gathering for the afore said: to establish educational aid to schools and public institutions thru demonstrations, and lectures concerning Native American people and true Native American history. An object of this corporation not for profit shall be to preserve, teach, and demonstrate the difference in the Native American Language, dances, traditions, religion and culture, to expedite the use of printed materials as teaching aids. Withlacoochee Native American Indian Culture, Incorporated also shall coordinate and/or participate in American Indian celebrations and demonstrations of Native American Peoples, to establish and maintain the rights of all Native American Indian Peoples for mutual advancement and growth. The incorporation, not for profit, filing under the Internal Revenue Service code 501-C (3) shall establish By-Laws and make all rules necessary to expediently manage its affairs; and to take, hold, manage, and dispose of all property real and personal of said incorporation.

Article IV

The eligibility for full membership in this incorporation, not for profit: shall be:

Membership shall be open to all persons who are interested in furthering the charitable purpose of this incorporation as set forth in Article III. Membership status shall be determined by the Board of Directors in the adoption of By-Laws and amendments thereto from time to time, and may embrace the qualifications for active, inactive, honorary, sustaining and lifetime membership, and establish membership fees therefore.

The Board of Directors in the adoption of By-Laws and amendments, if any, for the various classes of membership shall determine dues, from time to time thereto.

Article V

The Term of Existence:
