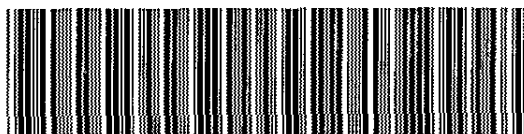

ARTICLES OF INCORPORATION
OF

The undersigned subscribers to these Articles of Incorporation hereby form a corporation not for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is **CROSSROADS RESTORATION CHURCH, INC.** with its initial principal office at 3615 78th Avenue East Sarasota, Florida 34243.

ARTICLE II - DURATION

The existence of this corporation shall begin when these Articles of Incorporation have been filed with the Department of State of the State of Florida. This corporation is to exist perpetually.

ARTICLE III - GENERAL PURPOSES

The general purpose for which this corporation is organized and the general nature of activities to be conducted by this corporation shall be:

To provide for worship and instruction in the Christian faith; to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located; to promote home and foreign missions; and, to aid in the dissemination of the Gospel of Jesus Christ; and to do and perform any other charitable acts or things, and to have and exercise any and all powers and privileges now or hereafter conferred by law upon a corporation not for profit in the State of Florida and to conduct any and all lawful activities for which corporations not for profit may be incorporated under the Florida Not For Profit Corporation Act.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

For the purpose of promoting the foregoing objectives, this corporation shall have the right to acquire; either by gift or purchase and to hold, own, sell, mortgage, or encumber in any manner, lease and improve real estate and personal property for itself and others.

ARTICLE IV - MEMBERSHIP

Members shall be admitted as set forth in the By-Laws of the corporation.

ARTICLE V - REGISTERED OFFICE AND AGENT

This corporation shall have a Board of Directors initially consisting of three (3) directors. The number of directors may be increased from time to time by the By-Laws of this corporation, but in no event shall the number of directors be less than three (3). 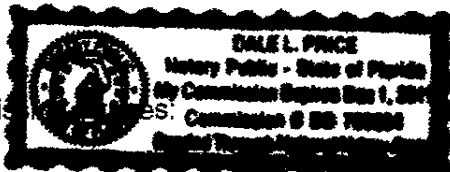
