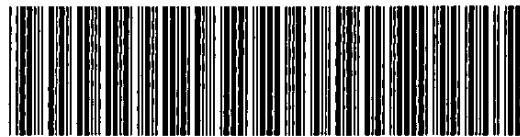

## ARTICLES OF INCORPORATION

The undersigned, being three natural persons competent to contract, acting as incorporators of a Corporation Not For Profit, under the Corporation Not For Profit Law of the State of Florida, (F.S. 617) do hereby adopt the following Article of Incorporation for such Corporation.

### FIRST

The name of the Corporation shall be THE HELPING HAND MINISTRIES INC.

### SECOND

The corporation is organized exclusively for religious purposes and will engage in such activities as will prepare people for The Kingdom of God, including teaching and disseminating Christian Beliefs, conducting religious material, and promoting in general the practice of Christian Principles as revealed in The Holy Bible. To accomplish its purposes, this corporation shall have all the powers permitted to Corporations under the Florida Not For Profit Corporation Act, and any power necessarily implied therefrom.

### THIRD

The members of the corporation shall be those who publicly declare their acceptance of and their willingness to adhere to the principles of Christian Living as revealed in The Bible, and who covenant to follow the Commandments of God and the Faith of Jesus. Such persons as described above, may be admitted to membership following baptism, upon the profession of their faith or upon recommendation and transfer from a church or congregation similar in beliefs and doctrine, to THE HELPING HAND MINISTRIES INC. In all cases, except for persons who have heretofore been associated with HELPING HAND MINISTRIES INC. not incorporated, and who shall become members upon the adoption filing and approval of these Articles of Incorporation, those persons qualifying for membership as described above, shall be admitted to membership upon a majority vote of the members present and voting at any regular or special meeting THE HELPING HAND MINISTRIES INC.

### FOURTH

The Corporation shall have perpetual existence.

#### SIXTH

The affairs of the corporation shall be managed by a President, a Treasurer, and a Secretary, who shall be elected annually at a general business meeting of the corporation, which shall normally be held on the last Saturday of each calendar year. Such general business meeting may, however, be scheduled upon notice to the membership on any convenient day in the last calendar month of each year. The Corporation may provide in its by-laws for the election of one or more Vice-Presidents and such other officers as may be deemed necessary.

#### EIGHT

The corporation shall have a Board of Directors initially comprised of three persons. The names and addresses of the persons who are to serve as Directors of THE HELPING HAND MINISTRIES INC. until the first election of members of the Board of Directors, under these Articles of Incorporation are as follows:

#### NINTH

The membership of THE HELPING HAND MINISTRIES INC. by a two third majority may make alter or rescind such by-laws as may be necessary for the governance and operation of the corporation, provided that the members present and voting at any regular or special business meeting of the corporation called for such purpose shall be constitute at least thirty three percent of the membership of the corporation.

#### TENTH

Amendments to these Articles of Incorporation may be proposed and adopted as follows: .Any member of the corporation in good standing may propose an amendment to these Articles of Incorporation. Such proposed amendment must first be submitted in writing to the Board of Directors of the Corporation, before bringing it before the general membership for consideration. The Board of Directors and the C.E.O. may make recommendations but final action thereon is subject to the vote of the entire membership of the

corporation. All proposed amendments to these Articles of Incorporation must receive the affirmative vote of at least a two-thirds majority of the members present and voting at any regular or special business meeting called for such purpose, provided that proper notice of such meeting shall have been given either at a previous regular business meeting or by notice in writing at least twenty days prior to such special meeting. Amendments to these Articles of Incorporation when adopted by the membership of the corporation, must also be forwarded to The Secretary of State of Florida, and filed and approved by him, before the same shall become effective.

#### ELEVENTH

The Corporation shall have its principal place of business in Miami, Dade County, Florida. The address will be 19450 SW 125 Ave. Miami, Florida 33177.

#### TWELFTH

The registered office of THE HELPING HAND MINISTRIES INC. shall be 19450 SW 125 Ave. Miami, FL 33177, and the registered Agent thereat is ERIC KRIGGER.

#### THIRTEENTH

THE HELPING HAND MINISTRIES INC. shall have or issue no shares of stock. NO part of the net earnings of the corporation shall inure to the benefit or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Second Article hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

#### FOURTEENTH


All the activities of THE HELPING HAND MINISTRIES INC. shall consist entirely of activities which are permitted to corporations organized exclusively for charitable, religious or scientific purposes within the meaning of Sec. 501 (c) (3) of the Internal Revenue Code of 1954, any other provision of these articles notwithstanding.


#### FIFTEENTH


Upon the dissolution of the corporation, The Board of Directors shall after paying or making provision for payment of all the liabilities of the Corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner or to such organizations organized and operated exclusively for the purposes of the corporation in such manner or to such organizations organized and operated exclusively for charitable, educational religious or scientific purposes, as shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, or the Corresponding provision of any future United States Law, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the corporation then has its

principal office for such purposes or to such organizations as said court shall determine consistent with the provisions of F.S. 617.05


