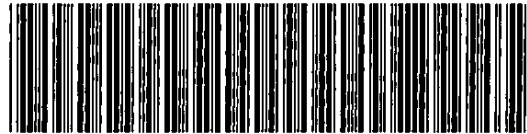

## ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

### **ARTICLE I NAME**

The name of the corporation shall be:

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

- A. The specific purposes of this corporation are to operate charitable and educational programs and facilities; the primary activity of which shall be the administration of a K-12 nonpublic, private school within the State of Florida with supportive activities and services it deems necessary. It may also conduct any lawful business or school activity needed to support, promote, and perpetuate it's existence.
- B. Exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.
- C. Provided, however that the corporation shall not engage in any action which is not permitted to be carried on by nonprofit corporations under the Internal Revenue Code; but the corporation shall be authorized and empowered to pay reasonable compensation to its members, directors, and officers for services rendered, and to make payments and distributions in furtherance of its stated purposes.

### **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed shall be by majority vote of the Voting Members at any properly called meeting of such Voting Members.
