ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be Abundant Life Christian Church Auburndale, Corp.

Article II Principal Office

The principal place of business of this corporation shall be: 231 E. Lake Ave.,
Auburndale, Florida, 33823 and its official business mailing address shall be 907 Ave. V
SE, Winter Haven, Florida, 33880

Article III Purpose

The purpose for which the corporation is organized is for the business of a New
Testament Christian Church. The church's purpose is to continue the mission of Jesus
the Christ in seeking and saving the lost and giving life more abundantly.

Article IV Manner of Election

The manners in which the directors and officers are elected or appointed are consistent

Deacons shall be appointed to serve in a specific ministry by the Senior Minister and
Elders.
