**AMENDMENT TO
ARTICLES OF INCORPORATION OF
CHRIST THE KING EVANGELICAL LUTHERAN
CHURCH AND PRESCHOOL (WELS) INC.**

The undersigned, the Pastor of CHRIST THE KING EVANGELICAL LUTHERAN CHURCH AND PRESCHOOL (WELS) INC., a Florida not-for-profit corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act, states as follows:

1. The current name of the Corporation is CHRIST THE KING EVANGELICAL LUTHERAN CHURCH AND PRESCHOOL (WELS) INC.
2. The Articles of Incorporation of the Corporation are amended by deleting Article I in its entirety and inserting the following Article I in its place and stead:

**ARTICLE
I**

"The name of the corporation is: CHRIST THE KING EVANGELICAL LUTHERAN CHURCH (WELS), INC."

3. There are no members entitled to vote on the Amendment. The Amendment was adopted by the Board of Directors.
