ARTICLES OF INCORPORATION

OF

J. IRA AND NICKI HARRIS FAMILY FOUNDATION, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation will be J. Ira and Nicki Harris Family Foundation, Inc.

ARTICLE II PRINCIPAL OFFICE

The street address of the principal place of business and the mailing address of this corporation will be: 220 Sunrise Avenue, Suite 210, Palm Beach, FL 33480.

ARTICLE III ORGANIZATION FOR CHARITABLE PURPOSES

- This corporation is organized and will be operated exclusively for charitable purposes as specified in Section 501(c)(3) of the Internal Revenue Code, and will not carry on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or any successor section, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or any successor section.
- The corporation will apply the net income, and any part or all of the principal, of such property as the corporation may from time to time possess, in aid of the prior enumerated purposes, including the giving of such income and principal to any other domestic or foreign charitable organization that is organized and operated exclusively for charitable purposes as specified in Section 501(c)(3) of the Internal Revenue Code.
- No part of the net earnings of this corporation will inure to the benefit of any director or officer of the corporation or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation), and no director or officer of the corporation or any private individual will be entitled to share in the distribution of any of the corporate assets on dissolution of the corporation.
- No substantial part of the activities of the corporation will be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Internal Revenue Code Section 501(h)), nor will the corporation participate in or intervene in (including the

publication or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLES IV MANNER OF ELECTION OF DIRECTORS

The method of election of directors of this corporation will be stated in the corporation's bylaws.

Upon liquidation or dissolution of this corporation, whether voluntary or involuntary, after payment of all debts and liabilities of the corporation of whatsoever kind or nature, its remaining funds and other property and rights will be distributed to an organization or organizations exempt from taxation under Section 501(c)(3) of the Internal Revenue Code, or any successor section, such organization or organizations to be selected by the directors of the corporation.
