The undersigned, for the purpose of forming a not-for-profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

#### ARTICLE I. NAME

The name of this corporation shall be THE SEAN GREEN PERFORMING AND FINE ARTS ACADEMY, INC. (hereinafter called the "Corporation").

# ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is 1947 STRATFORD WAY, WEST PALM, FLORIDA 33409.

## ARTICLE III. PURPOSE

This Corporation is a not-for-profit corporation, organized for charitable, religious and educational purposes in Section 501 (c) (3) of the Internal Revenue Code 1986 and for the purpose of engaging in any lawful act or activity not for pecuniary profit for which not-for-profit corporations may be organized, so far as is or may be permitted by the laws of the State of Florida and Section 501 (c) (3) of the Internal Revenue Code of 1986 as amended.

The specific purpose of the Corporation is to educate and enrich the quality of life for youths in underserved communities by providing a conglomerate of high-quality performing and fine arts educational programs, which will instill a passion for the arts that will last a lifetime. The SGP&FA Academy also provides the training necessary to attain personal excellence and strengthen self confidence while supporting wholesome family and communal values.

# ARTICLE IV. MEMBERSHIP

Any person, relative, corporation, partnership, association or organization, who is interested in the purposes of the Corporation, who is capable of contributing to the achievement of those purposes and the effective operation of the Corporation, and who complies with the requirements established from time to time by the Bylaws, shall be eligible for membership.

# ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 1009 A3 GREEN PINE BOULEVARD, WEST PALM BEACH, FLORIDA 33409. The initial registered agent shall be TIMOTHY LAMAR SHANNON.

# ARTICLE VI. BOARD OF DIRECTORS

The affairs of this Corporation shall be managed by a Board of Directors consisting of no less than three (3) directors. The number of the directors may be increased or decreased from time to time, in accordance with the Bylaws of the Corporation, but shall never be less that three (3). The manner of election of directors shall be regulated by the Bylaws.

# ARTICLE VIII. DISSOLUTION

Upon the dissolution or winding up of this Corporation, its assets remaining after payment, or provisions for payment, of all debts and liabilities of the Corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code 1986, as amended, or corresponding provisions of any subsequent federal tax laws.

# ARTICLE IX.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, it's directors, officers, members or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation (except as otherwise provided in subsection (h) of Section 501 of the Internal Revenue Code of 1986, as amended), and the Corporation shall not participate or intervene in (including the publishing or distributing of statement) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue law).
