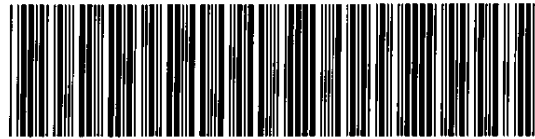

Amend Article II to read:

"The principle place of business address:

Amend Article III to read:

The specific purpose for which this corporation is organized is:

"Mary's Place, Inc. d/b/a Life Choices Women's Center, heretofore referred to as the corporation, is organized exclusively for charitable purposes. Said corporation exists to provide women in crisis pregnancies with necessary support services to enable them to carry their babies to term. Such services shall include, but not be limited to, providing: free pregnancy tests, maternity and baby supplies, referrals for low cost legal and medical help, temporary housing and shelter, parenting education, abstinence and fertility education, adoption referrals, post-abortion counseling, and ongoing friendship and encouragement. "

Amend Article VIII to read:

"Conflict of interest:

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision in these bylaws, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code. "

Add Article IX:

"Dissolution:

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization/s, as said Court shall determine, which are organized and operated exclusively for such purposes."
