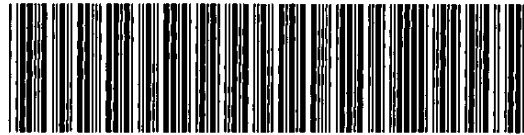

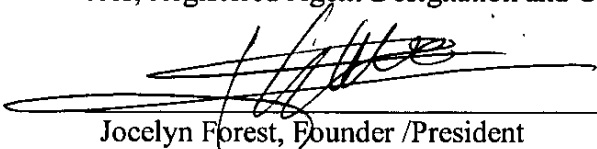

IN COMPLIANCE WITH CHAPTER 617, F.S. (NOT- FOR-PROFIT)

The undersigned, for the purpose of forming a not-for-profit Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**Article I**

**Name**

The name of this Corporation shall be; International Organization Of The Development Of Haiti, Inc. The Corporation is organized pursuant of the Florida Non-profit Corporation codes.

**Article II**

**Principal Office and Mailing Address**

The principal Office and mailing address of the Corporation is 2389 Greengate Cir Apt G, West Palm Beach, FL. 33415

**Article III**

**Purpose**

The specific purpose of this not-for-profit Corporation is for charitable, Religious, Social Development, and Education Training purpose in Section 501(c) 3 of the Internal Revenue Code 1986, and for the purpose of engaging in any law act or activity not for pecuniary profit for which not-for-profit Corporation may be organized, so far as is , or may be permitted by law of the State of Florida Section 501 ( c ) 3 of the Internal Revenue Code 1986, as amended. Also, there are several outreach projects/ programs organized to operate through the International Organization Of Development Of Haiti, Inc: Literacy/ Reading program (L.R.P), Business Entrepreneurship program (B.E.P), Health Education Program (H.E.P), Child Abuse Prevention (C.A.P), Teen Pregnancy Prevention (T.P.P), Delinquency Outreach Prevention Program (D.O.P.P), Personal development Program (P.D.P), Community Scholarship Assistance (C.S.A), Computer Technology Program (C.T.P), Age Enrichment program (A.E.P), etc.

**Article IV**

**Membership**

Any Person, relative, Corporation, partnership, association or organization who is interested in the Corporation, who is capable of contributing of those purposes and the effective operation of the Corporation, and who complies with the requirements established from time to time by the by- laws, shall be eligible for membership.

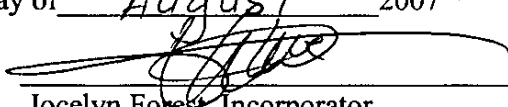
**Article VIII**  
**Dissolution**

Upon the dissolution winding up of this Corporation, its assets remaining after paying or provision for payment of all debts and liabilities of the Corporation shall be distributed to non-profit fund, foundation or Corporation, which is organized and operated exclusively or charitable purpose and which has established its tax exempt status under the Section of The 501 (c) 3 of the Internal Revenue Code 1986, as amended or corresponding provisions of any subsequent federal tax laws.

**Article IX**  
**Limitations**

Not part of the net earning of the Corporation shall insure to the benefit of, or be distributed to its directors, Officers, Members or other private person, except that the Corporation shall be authorized and empowered to reasonable compensation for services rendered and to make payment and distributions in furtherance of any its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislations( except as otherwise provided in subsection ( h) of section 501 (c ) 3 of the Internal Revenue Code 1986, as amended), and the Corporation shall not participate or intervene in( including the publishing or distribution of statement) any political campaign of behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under the Section 501 (c ) 3 of the Internal Revenue Code 1986, as amended ( or the corresponding provision of any future United States Internal Revenue law), by ( b ) a Corporation, contributions to which are deductible under the section 170 (c ) (2 ) of the Internal Revenue Code 1986, as amended ( or the corresponding provision of any provision of any future United States Revenue Law).
