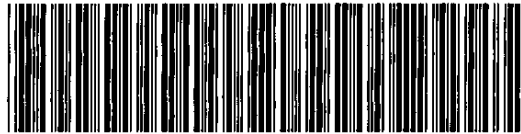

- TWO:** This corporation is a nonprofit religious benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Religious Benefit Corporation Law for, Religious and Charitable purposes. To establish Churches through out the United States and the world by training ministers and pastors, and other Ministries for the Body of Jesus Christ (The Church).
