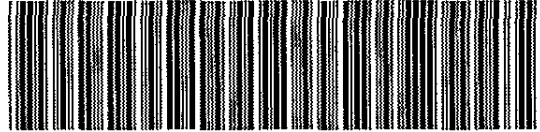

ARTICLES OF INCORPORATION

OF

WAR VETERANS OF FINLAND HERITAGE GUILD VETERAANI TUKI, INC.
PALM BEACH COUNTY, FLORIDA

ARTICLE I - NAME

The name of this Corporation is WAR VETERANS OF FINLAND HERITAGE GUILD
VETERAANI TUKI, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this corporation shall be:
3160 Lake Osborne Drive apt.110, Lake Worth, FL 33461-5941.

ARTICLE III - PURPOSE

The main purpose of this Corporation is to promote good fellowship and understanding among its members and the purpose for which the Corporation is organized are exclusive charitable, religious, scientific, literary and educational within the meaning of section 501(c) (3) of Internal Revenue Code or the corresponding provisions of any future United States Internal Revenue law. No substantial part of the activities of this corporation shall be devoted to carrying on political propaganda or taking part in political campaigns.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

Directors are elected and/or appointed by The Annual Meeting of The Corporation held yearly in February.

ARTICLE V - DEDICATION OF ASSETS

No part of the net income or assets of the corporations shall be to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the corporation in carrying out one or more of its purpose.

ARTICLE VI - DISTRIBUTING OF ASSETS UPON DISSOLUTION

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the corporation, dispose of all assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated exclusively on charitable, educational, religious, or scientific purposes as shall at time qualify as an exempt organization or organizations, as the Board of Directors shall determine.

ARTICLE VII - QUALIFICATION OF MEMBERS

The qualification for members and the manner of their admission shall be regulated by the Bylaws.

ARTICLE VIII - BY-LAWS

The power to adopt, alter, amend or repeal By-Laws shall be submitted by the Board of Directors for approval of a general meeting of the corporation.

ARTICLE IX - INITIAL REGISTERED AGENT

The initial registered agent is Aarne A. Aaltonen at 3160 Lake Osborne Drive, apt.110, City of Lake Worth, County of Palm Beach.

ARTICLE X - BOARD OF DIRECTORS

The business and affairs of this corporation shall be managed and be under the direction of the directors of this corporation.
