This letter is to inform you, that the Mount Olive Missionary Baptist Church of South Bay, Inc. and its Board Members did not grant authorization to Dr. Randy Lamar Burden, Jr. or any members of the House of Prayer s including officers, etc. to change our corporation name from the Mount Olive Missionary Baptist Church of South Bay, Inc. To The House of Prayer Non – Denominational Church of Belle Glade, Inc.

This problem has been on going beginning specifically with November 2, 2017, wherein Dr. Randy Burden had no legal rights to add himself to the corporation or make any amendments.

On June 30, 2021, The Board Members of Mount Olive amended our corporation removing him as Pastor of the Mount Olive Missionary Baptist Church, Inc. and added a new President (Rev. Dr. Michael Davis).

Letter of Cease and Desist

Dear Dr. Randy Burden, Jr.

We the Mount Olive Missionary Baptist Church of South Bay, Inc. membership is issuing to you and your congregation named the House of Prayer a formal and friendly request that you please surrender anything that was purchased or is owned under the name of Mount Olive Missionary Baptist Church of South Bay, Inc. which physical location is 1424 West Canal Street South, Belle Glade, Florida 33430.

Please refrain from entering the property located on 1424 West Canal Street South, which is inclusive of changing the locks on the property and having the Mount Olive Missionary Baptist Church members to have to have worship service on the outdoors. The property is owned by the Mount Olive Missionary Baptist Church, Inc. which is a Non - Profit Corporation.

Under the laws of the State of Florida, The Mount Olive Missionary Baptist Church of South Bay, Inc. is a Non - Profit corporation and does have the option(s) to file criminal charges for the acts that have been discovered that was recently committed by you. This may lead to Criminal and Civil charges against you.

If we are forced to commenced to bring a lawsuit to address the intentionally disruptive and damaging actions, be also advised that all legal fees we incur we will seek recovery for them. We sincerely hope that you would concur and surrender anything under the Mount Olive Missionary Baptist Church of South Bay Inc. name.

This is our second attempt to reason with you regarding this matter of trespassing, releasing the credit and debit cards as well as the checkbook and records under the name of the Mount Olive Missionary Baptist Church of South Bay, Inc.

Dear Church Members:

We are gathered to discuss not only changing the name, but to eliminate the denomination as the Pastor does not agree with the Baptist Denomination of the Church. This Church was founded and established as Missionary Baptist Church and later incorporated according to the laws of the State of Florida. We have come through some difficult times, but God has delivered us over and over again. Many of our older members are sick and unable to attend on a regular basis and now we are confronted with another challenge but this time it is from within.

While we were established as a Missionary Baptist Church, our Pastor has decided that the Baptist Name on the Church is hindering the growth of the Church. He has been adverse to the Baptist, though his credentials were issues by a Baptist Association. If he is not a Baptist, then he does not have the authority to preside over a Baptist congregation.

According to research done on the church incorporation on Sunbiz, the church is registered as a baptist church, namely Mount Olive Missionary Baptist Church of South Bay, Inc. that is over 80 years. According to the records you and 5 other members are listed on the corporation papers. In order to change the name of the church, the members listed on the corporation must agree to dissolve the church named under Mount Olive.

Mt. Olive has property and funds in a Bank that should for the benefit of this Church and its members.

This letter is a notice to the Pastor and others that legal action will be pursued to prevent this travesty from occurring.

Join me today and say no to Rev. Burden's request. If he desires to start another, then let him move on and take those who desire to follow him. Keep in mind that "God is Not the author of confusion."

5. At this we ask that you remove all personal items from our property on or before June 25, 2021 by 6:00 p.m. after the time you will be TRESPASSING SUBJECT TO ARREST AND PROSECUTED TO THE FULL EXTENT OF THE LAW.

6. We don't want fight you on this and hope this can be a peaceful separation if not we are willing do what is necessary to protect the Mount Olive family.
