The purpose of the meeting was to discuss renaming the to draw more people to Christ by being a non denominational church. Pastor Burden went on to outline the goals to the Deacons. At the end of the meeting, Pastor Burden asked the Deacons to vote on whether they would support him in renaming the church. If they voted yes, he would also move forward and have the congregation to vote as well. The Deacons; Carl Lymon, George Anderson as well as Pastor Burden voted yes to the name change. Deacon Johnny Atkins stated that he didn't want the name to change. Deacon Jackson- the fourth Deacon ( inactive for over two years ) was not in attendance at the meeting and the church Bylaws state that he had to be present to vote. The end vote was 3-1 in favor of changing the name of the church from Mt. Olive Missionary Baptist Church.

On May 30, 2021, Pastor Burden discussed the name change with the congregation and answered the questions everyone had. Pastor Burden informed everyone that the vote on the name change would take place on June 6, 2021 to allow everyone an opportunity to be in attendance and cast their vote.

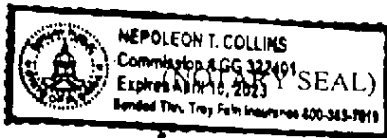
