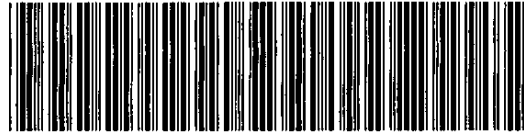

ARTICLES OF INCORPORATION  
of  
DOUGLAS ANDERSON SCHOOL OF THE ARTS THEATRE BOOSTERS  
ASSOCIATION, INC.

Article of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of The State of Florida, do hereby certify:

ARTICLE I. NAME

The name of the Corporation is Douglas Anderson School of the Arts Theatre Boosters Association, Inc.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The place in this state where the principal office of the Corporation is to be located and the mailing address is Theatre Department, Douglas Anderson School of the Arts, 2445 San Diego Road, Jacksonville, Florida, 32207, Duval County.

ARTICLE III. PURPOSES

Douglas Anderson School of the Arts Theatre Boosters Association, Inc. is a not for profit corporation organized exclusively for charitable and educational purposes, including, for such purposes, support of the Theatre Department of Douglas Anderson School of the Arts and the students of the Theatre Department. The general purpose for which the corporation is formed is to operate exclusively for purposes which will qualify it as an exempt organization under Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE IV. LIMITATION OF CORPORATE POWERS

The Corporate powers of this corporation are as provided in Florida Statutes. The Corporation shall not exercise any of its powers for pecuniary gain and shall not perform any function prohibited to corporations not-for-profit by law and statutes of the State of Florida.

ARTICLE V. ELECTION OF BOARD OF DIRECTORS

The manner in which the directors of this corporation are elected or appointed shall be as stated in the bylaws of the corporation.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

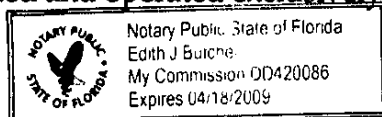

#### ARTICLE VII. DISSOLUTION AND ASSET DISTRIBUTION

Upon the dissolution of the corporation, assets shall be transferred to Douglas Anderson School of the Arts for use by the Douglas Anderson Theatre Department or distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
