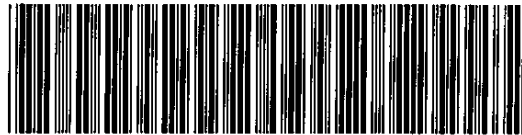

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of incorporation.

ARTICLE I

The name and address of this principal corporation is Good Growth Homes Inc. 410 S.W. 30th Terrace, Fort Lauderdale, FL 33321.

ARTICLE II

The principal place of business and mailing address of this corporation shall be: 410 S.W. 30th Terrace, Fort Lauderdale, 33321, in Broward County. The organization is organized pursuant to the FLORIDA Non-Profit Corporation Code.

ARTICLE III

This corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Non-Profit Public Benefit Corporation Law, for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Seminars, Outreach Advocacy Programs for the Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement, and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care and other programs to aid those in need.

ARTICLE IV

The corporation shall have 3 directors and collectively they shall be known as the Board of Directions. The number may be changed by resolution of the By-Law, or by repeal of the By-Law and adoption of a new By-Law, as provided in the By-Laws. Each Director shall hold office until the next annual meeting for election of the Board of Directors as specified in these By-Laws, and until his or her successor is elected and qualified. On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and

operated exclusively for, Charitable and Educational under Section 501© (3) of the Internal Revenue Code

ARTICLE V
