## ARTICLES OF INCORPORATION Animate Objects Physical Theater, Inc. A Florida "Not for Profit" Corporation

The undersigned, acting as incorporator of a corporation under Chapter 617 of Florida Statutes, adopts the following Articles of Incorporation:

#### Article I NAME

The name of the corporation is Animate Objects Physical Theater, Inc.

## Article II PRINCIPAL OFFICE & MAILING ADDRESS

The principal office of the corporation is located at 2902 W. Trade Ave Miami, FL 33133

Such office may be changed at any time by the Board of Directors without amendment of the Articles of Incorporation.

The business of this Corporation may be conducted in all counties of the State of Florida and in all states of the United States, and in all territories thereof, and in all foreign countries as the Board of Directors shall determine.

#### Article III PURPOSE

The specific purposes and objectives of the Animate Objects Physical Theater,
Inc. shall include but not be limited to the following:

(a) Animate Objects Physical Theater, Inc. is organized as a nonprofit corporation and shall be operated exclusively for educational and charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

- (i) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the Corporation and to make payments and distributions in furtherance of the purposes set forth herein:
- (ii) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Internal Revenue Code of 1954, as amended;
- (iii) The corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal Revenue law);
- (b) To act and operate exclusively as a nonprofit corporation pursuant to the laws of the State of Florida;
- (c) To present exciting and innovative performance works in conventional theaters and in unexpected settings through an integration of contemporary dance, movement-based theater, aerial dance and other circus arts;
- (d) To present non language-specific performance works that reach beyond cultural barriers to impact an international audience;
- (e) To offer outreach and educational programming that serves to encourage participation and raise awareness of the arts for children through adults;
- (f) To solicit and receive contributions, purchase, own and sell real and personal property, to make contracts, to invest corporate funds, to spend corporate funds for purposes, and to engage in any activity "in furtherance of, incidental to, or connected with any of the other purposes;"
- (g) Such other powers as may be exercised by nonprofit organizations under the applicable laws of the State of Florida.

### Article IV MANOR OF ELECTION

Recommendations for board members are accepted from current board members and selected by a majority vote.
