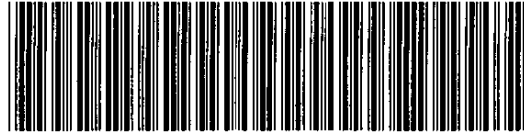

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Exclusively Ecclesiastical, charitable, educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, as now enacted or amended, including for such purposes the making of distribution to organizations that also qualify as section 501(c)(3) exempt organizations, also for the spreading of the Gospel of Jesus Christ, ministering to the homeless, needy, sick, helpless, and aged. Upon dissolution of the corporation any assets remaining after payments of all obligations shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Jurisdiction of the county in which the principal office of the corporation is located exclusively for the purpose or to such organizations or organizations exclusively for such purposes. NO part of net earning of this corporation may inure to the benefit of any members, officers or directors.
