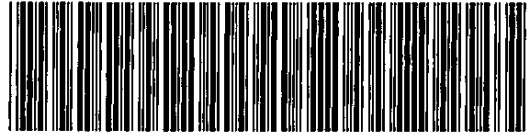

ARTICLE ONE

NAME OF ORGANIZATION

- (1) The name of this organization shall be:
DIVINE DESTINY MINISTRIES INTERNATIONAL, INC.

ARTICLE TWO

ARTICLE THREE

PURPOSE

- (1) The following are the purposes for which this organization has been organized:
- a. To bring people to a saving knowledge of Jesus and spread the Gospel of the Kingdom throughout the world.
 - b. To bring people to the understanding of their divine destiny or purpose.
 - c. To introduce the believer to a life of biblical transformation in Jesus Christ.
 - d. To teach and instruct the body to become representatives and ambassadors of Christ in the earth and to the nations.
 - e. To teach the believer to walk in dominion, authority, and power in the earth and in the realm of the Spirit.

- (2) This organization is organized exclusively for charitable, religious, and/or educational purposes under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.
- (3) This church shall be a not for profit corporation.

- (1) At all meetings except for the election of officers and directors all votes shall be viva voce, except that for election of officers ballots shall be provided and there shall not appear any place on such ballot any mark or marking that might tend to indicate the person who cast such ballot.

- (2) At any regular or special meeting if a majority so requires any question may be voted upon in a manner and style provided for election of officers and directors.
- (3) At all votes by ballot the chairman of such meeting shall immediately prior to the commencement of balloting appoint a member as "Inspector of Election" and who shall at the conclusion of such balloting certify in writing to the Chairman the results and the certified copy shall be physically affixed in the minute book to the minutes of that meeting.

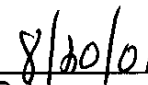

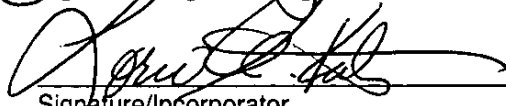

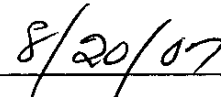
