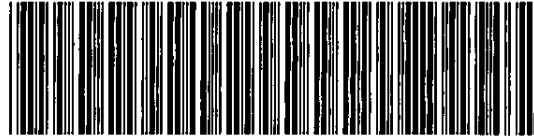

Article I NAME

Article II PRINCIPLE OFFICE

The principal place of business and mailing address of this corporation shall be: 7506 Central Park Circle, Tampa, Florida 33637 (Subject to Change)

Article III PURPOSE

The purpose for which this corporation is organized is: To establish a faith based foundation that ministers and promotes the teachings of JESUS CHRIST. Ministering to the needs of individuals who are Homeless and seeking Life Recovery. Providing Transitional Housing, Educational Training, and preparation for Self-sufficiency. This Corporation is organized exclusively for one or more of the purposes as specified in Section 501 C 3 of the Internal Revenue Code.

Article IV MANNER OF ELECTION

This corporation chooses the Non membership status, and makes no provisions for members. Directors possessing strong managerial, technical, and financial skills who will be a crucial link between the organization, its supporters, and benefactors. (Sole discretion of Directors are subject but not limited to description above.) At the regular meeting of directors held December 23rd of every third year, directors shall be elected by the board of Directors. Voting for the election of Directors shall be by written ballot. Each Director shall cast one vote per candidate, and may vote for as many candidates as the number of candidates to be elected by the board. The number of votes up to the number of directors to be elected shall be elected to serve on the board.
