**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
THE TELECOM CONDOMINIUM ASSOCIATION, INC.**

Pursuant to the Florida Business Corporation Act, The Telecom Condominium Association, Inc., a Florida not for profit corporation (the "Corporation"), adopts the following Articles of Amendments to its Articles of Incorporation:

ARTICLE I

Name

Amendment

Article I of the Articles of Incorporation is deleted in its entirety and replaced with the following:

"I.

Name

The name of the corporation is The Telecom at River Bend Condominium Association, Inc. For convenience the corporation shall be referred to in this instrument as the Association"
