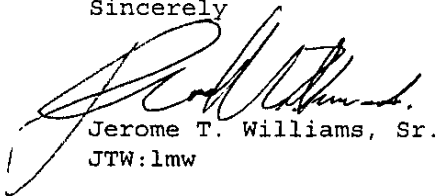

**ARTICLES OF INCORPORATION
OF**

**OLE RIDERS MOTORCYCLE CLUB, INC.
A FLORIDA CORPORATION NOT FOR PROFIT**

I, the undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, Chapter 617 Florida Statutes, do hereby adopt the following articles of incorporation:

ARTICLE I

The name of the corporation is **OLE RIDERS MOTORCYCLE CLUB, INC.**

ARTICLE II

The mailing address of the initial registered office of the corporation is 2525 N. Main Street, Ste. #1, Jacksonville, Florida 32206 which shall also serve as the principal place of business.

ARTICLE III - PURPOSES

(a) The specific and primary purposes for which this corporation is organized is to provide residential use for its' members.

(b) The general purposes for which this corporation is formed are to bring its members together on a periodic basic and to promote religious business among them.

This corporation shall have a perpetual existence.

ARTICLE IX

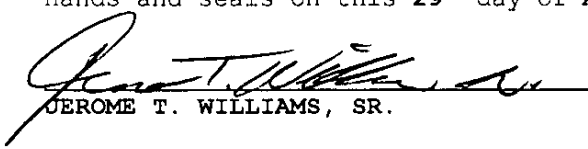

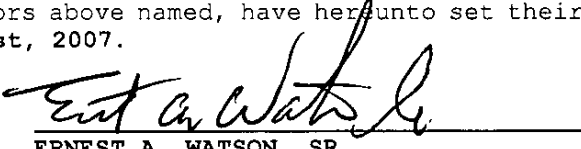
ARTICLE X - AMENDMENT OF ARTICLES

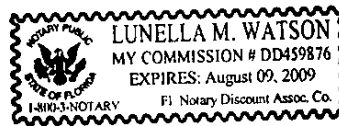
