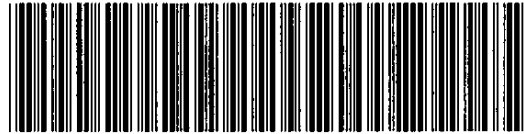

**ARTICLE I NAME**

The name of the corporation shall be:

**IGLESIA PENTECOSTAL MIRAD QUE NADIE OS ENGAÑE, INC.**

Changes to the name could be made in the future if necessary.

**ARTICLE II PRINCIPAL OFFICE**

**ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

1. Establish churches or incorporate already established churches that want to be part of the corporation. Any church interested in been incorporated to this corporation will need to pass an initial evaluation by the President of the corporation, and must accept the corporation's Constitution and Statement of Faith. These churches can have the same name of the corporation or a different one. In the case of a different name, the church name has to include the phrase: "Incorporated to Iglesia Pentecostal Mirad Que Nadie Os Engañe, Inc."
2. Recognize and ordain ministers (pastors, evangelists, prophets, teachers, missionaries, etc.) that preach and teach the Bible in accordance to the organization's Statement of Faith. These ministers will receive a credential card that will serve as a formal document that states that they are recognized by the organization as part of the ministry. The president and one officer will sign these credential cards. The cards will be renewed every year or whenever the president considers necessary. The ministers that leave the organization or violate the Corporation's Constitution and/or Statement of Faith will be required to return the credential card to the organization, and will not receive a new one until authorized by the president.
3. Teach and preach the Bible using all types of methods: person-to-person, media (radio, TV, literature, newspaper, internet, CD, video, etc.), etc.
4. Distribution of religious material free of charge, or with suggested donation in particular cases.

5. Provide free pastoral and biblical counseling.
6. Establish new ministries that can include theological seminaries, schools, day cares, drug rehabilitation centers or any type of institution that provide religious or social help to the society.

#### **ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:

**The Registered Agent / Incorporator/ President will be initially electing the Board of Directors. Once the president considers that the corporation is stable and fully capable of electing new officers, the president will announce the changes and will use a free election as the method to elect the Board of Directors.**
