We the undersigned, hereby associate ourselves together for the purpose of forming a Corporation not for profit under Chapter 617, the Laws of the State of Florida, and in accordance with the following Articles of Incorporation.

**I**

The name of the Corporation shall be:

**MYSTIC BROTHERHOOD COUNCIL NO 35 KNIGHT MASONS OF THE USA, INC.,**  
and its initial principal office shall be 3602 West Euclid Avenue, Tampa, Hillsborough County, Florida 33629, with the right to change and move said principal office within or without the State of Florida as the Board of Directors may from time to time deem proper.

**II**

The duration of this Corporation is perpetual. The corporate existence of this corporation shall commence on the date these Articles of Incorporation are executed.

**III**

The general nature and object of this Corporation shall be the promotion of good fellowship among Free Masons and exemplify the various Masonic Degrees under the authority of Grand Council of the Knight Masons of the USA, whose headquarters is in Washington,, D. C..

**IV**

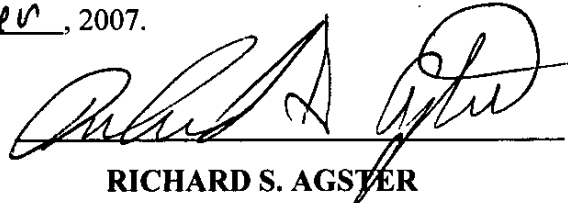
who shall constitute the initial members of the corporation.

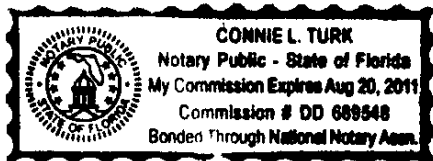
