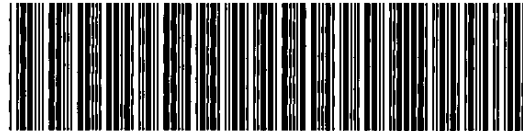

ARTICLE I
Name

The Name of this corporation shall be the "The Inspire Group", Inc. Hereafter referred to as The Inspire Group, Inc.

ARTICLE II
Principle Place of Business and Address

The principle office of this corporation is in Tallahassee, Florida. The mailing address of the corporation is 3543 Sundown Rd., Tallahassee, Fl., 32305

ARTICLE III
Purpose

This program is organized and shall be operated exclusively for charitable purposes and qualify for tax exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, for the purpose.

The mission of The Inspire Group, Inc. is to instill values, improve the social well being of youth most in need while recognizing and building upon the interaction of other youth who posses strong and moral character.

ARTICLE IV
Board of Directors

The Board of Directors (Board) of The Inspire Group, Inc. shall be composed of both elected and appointed members. The elected members shall be the presiding officers and shall consist of a chair, vice-chair, secretary and treasurer.

The elected officers, along with the Executive Director of the program shall make up the Executive Committee of The Inspire Group, Inc. The elected officers shall be nominated from the seated Board with a term of office not to exceed one year and up to two consecutive terms. Nominations can or will be made by any elective or appointed Board member.

Appointed Board members will consist of association, organization, business, faith-base, and community representatives and shall be invited to sit on the Sub-Committee with the approval Executive Director of The Inspire Group, Inc. The Board shall consist of not less that five and no more than fifteen members.

The Board shall be responsible for the development, management and control of the affairs, property and funds of the corporation and shall exercise all such powers and authority as expressly or by implication, conferred on them by these Articles of Incorporation, Bylaws of the corporation and the State of Florida.
