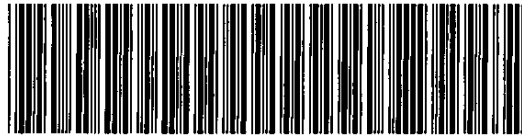

**ARTICALES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under Chapter 617 of the laws of the Florida, does hereby adopt the following articles of incorporation:

ARTICLE I NAME

The name of this Corporation shall be:

DELRAY BEACH PARENT GROUP, INC.

ARTICLE II PRINCIPLE PLACE OF BUSINESS

ARTICLE III PURPOSE

The purpose for which the corporation is to be formed is to raise funds for Educational and Social goals for low income, economically needed families with children. To represent the views and feeling of the parents of Delray Parent Group. To provide for education, security and welfare of the children's of the Delray parent group.

To build, repair, rehabilitate and maintain equipment used by the Delray parent group.

To receive and maintain funds of real or personal property, or both, and subject to the restrictions and limitations hereinafter set forth, to use and apply the whole or part of the income there from and the principles literary, or educational purpose either directly or by contributions under Section 501(c) of the Internal Revenue Code and its Regulations as they now exist or may hereafter be amended.

ARTICLE IV INITIAL DIRECTORS/OFFICERS
