ARTICLES OF INCORPORATION

- The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of this corporation is St. James Missionary Baptist Church of Bunnell, FL, Inc.

ARTICLE II: PRINCIPLE PLACE OF BUSINESS

The principle place of business for this corporation shall be: 609 S. State St., Bunnell, FL 32110. The mailing address is: P.O. Box 924, Bunnell, FL 32110. All correspondence shall be mailed to the Post Office Box.

ARTICLE III: PURPOSES

The specific purpose(s) for which this corporation is organized is (are): to spread the gospel of Jesus Christ and to proclaim the truths of His Holy Word from the King James Bible. The general nature of the objectives and purposes of this corporation shall be to administrate a church composed of a body of believers in Jesus Christ, organized to proclaim the gospel of Jesus Christ, and to teach the principals and precepts of Christianity as reveled in the authorized King James Bible. This corporation is organized exclusively for religious, educational and charitable purposes.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is stated in the official Church By Laws retained in the official records of the church and held in the corporate business office.

ARTICLE V: BOARD OF DIRECTORS, MEMBERSHIP & BUSINESS AFFAIRS

SECTION 1: Initial Board of Trustees

The business affairs of this corporation shall be managed by the Board of Trustees. This corporation shall have at least three (3) trustees at all times. The number of Trustees may be increased from time to time, by the by laws, but shall never be less than three. The Board of Trustees shall be members of the corporation and shall hold office in accordance with the by laws. The names and address of the persons, who are to serve as trustees for the ensuing year, or until the first annual meeting of the corporation, are:

SECTION 2: PROHIBITED ACTIVITIES

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, officers or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to not withstand any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

SECTION 3: MEMBERSHIP

The qualification of members and the manner of their admission or termination shall be regulated by the church by laws and covenant. We believe that God ordained and created all authority and that every person is answerable to God and governed by His word. All corporate powers will be limited only by His divine will.

SECTION 4: DISTRIBUTIONS ON DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusive for such purposes or to such organization of organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


ARTICLE VI: REGISTERED AGENT AND OFFICE

The name of the initial Registered Agent of the Corporation is Patrick A. Wilkerson. The street address of the initial Registered Office of the corporation is 609 S. State St., Bunnell, FL 32110. The mailing address is: P.O. Box 924, Bunnell, FL 32110.

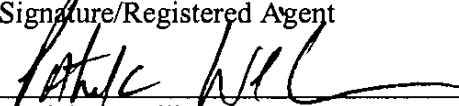
