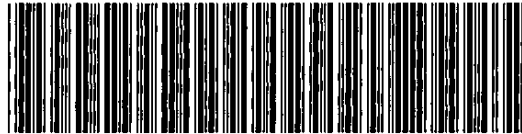

The name of corporation is Hunger Free Mission for Christ, Inc

II

A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific purpose of this corporation is to provide food and clothing for the poor of the area.
