- Establish Bank Account
 - Dennis Eason and Michael Clarke volunteered to be authorized signatures on the account
 - o It was agreed to open the account at the Compass Bank
 - Dennis Eason volunteered to obtain the necessary forms from the bank to start the account
- Tax Exempt Status
 - Mrs. Peggy Baldt, Esquire, has completed the application forms that will need to be submitted to the Internal Revenue Service
 - o It will cost \$300.00 to apply for the tax exempt status
 - o It was agreed to ask each member via e-mail to contribute a minimum of \$30.00 by 02-01-08 to raise the \$300.00

First ECM Action

- It was agreed that the first priority was to help subsidize the financial support to Mr. Reuben Badenock (minister, Union Island Church of Christ) that is received from the Argyle Church of Christ, Jacksonville, FL which is currently \$225.00 per month for 2008, and scheduled to be phased out by 2010.
- It was agreed to commit a minimum of \$200.00 per month for a duration of 2 years to Mr. Badenock's support starting in March 2008
- o It was agreed to ask each member for a commitment of a minimum \$20.00 contribution per month for 2 years (total of \$480.00 over that period) to provide the financial support to Mr. Badenock and begin building cash reserves for other needs
- ECM will need to define a list of expectations for Mr. Badenock in conjunction with the monthly financial support one of which is a required quarterly report of the work in Union Island
- Dennis Eason closed the meeting with a prayer.
