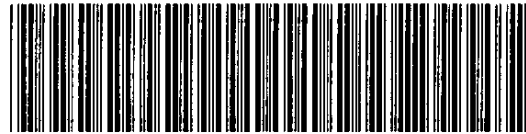

ATTACHMENT A

The object for which the corporation is established is to serve as a professional society for members of the interior redesign industry, within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, as amended (or any corresponding provision of any future United States Internal Revenue law), and specifically to serve as a regional constituent group of Interior Redesign Industry Specialists.

No part of the net earnings of the corporation shall inure to the benefit of any director, officer or other person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered.

Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations as shall at the time qualify as an exempt organization or organizations under Section 501(c) of the Internal Revenue Code of 1986, as amended (or any corresponding provision of any future United States Internal Revenue law), as the Board of Directors shall determine.

No additions, deletions or other changes in the articles of incorporation or by the bylaws of the corporation shall take effect with the approval of the Board of Directors of Interior Redesign Industry Specialists.
