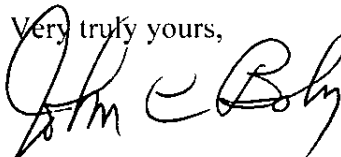

ARTICLE I

NAME

The name of this corporation shall be EGLISE EVANGELIQUE BAPTISTE  
BETHLEHEM WESTSIDE OF JACKSONVILLE, FLORIDA, INC.

ARTICLE II

PURPOSE

This corporation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, including, but not limited to, the establishing and maintaining of religious worship, the building of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, print shops, daycare centers, and camps; the evangelizing of the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; the educating of believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools of Christian education; and the maintaining of missionary activities in the United States and any foreign country.

This corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended.

This corporation is organized and operated exclusively for non-profit purposes and no part of any net earnings shall inure to the benefit of any member, director or officer.

Notwithstanding any other provision of the Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended, or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended.

**ARTICLE III**

**TERM**

The term for which this corporation shall exist shall be perpetual.

**ARTICLE IV**

**DIRECTORS**

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of three (3) to seven (7) directors as determined as specified in its Bylaws. Directors shall be elected in accordance with the Bylaws..
