Pursuant to Section 617.1401 of the Florida Business Corporation Act, the Plan of Dissolution of **MASJID EL FURQAN INC.**, a Florida not-for-profit corporation (hereinafter called the "Corporation") is as follows:

1. The Board of Directors approve, authorize and consent to the voluntary dissolution of the Corporation, such dissolution to be effective as promptly as possible after the organized, deliberate and proper winding up of its business affairs, satisfaction of its liabilities or adequate provision therefor, the transfer of its assets, and the filing of articles of voluntary dissolution in accordance with the Plan of Dissolution.

The Board of Directors hereby authorize the officers of the Corporation to, after the organized and deliberate winding down and completion of its business, the completion of its contracts and the disposition of its business, to file Articles of Voluntary Dissolution with the Secretary of State of the State of Florida.
