

## ARTICLE III PURPOSE

The purpose for which this corporation is organized is: (1) to educate and teach soccer to amateur athletes by organizing soccer teams composed of youths under the age of 19 who will play in local leagues operated under the guidelines of the Florida Youth Soccer Association (FYSA); (2) to foster national competitions by developing travel teams composed of youths under the age of 19, and teams to compete in state and national amateur soccer competition in tournaments held by the United States Youth Soccer Association (USYSA), a division of the United States Soccer Federation (USSF); and (3) to educate parents how to teach youths the sport of soccer.

### ARTICLE IV MANNER OF ELECTION

At each annual meeting of Directors, the Directors shall elect a Board of Directors, whom shall hold office until the next annual meeting. Currently the Board consists of three members and shall remain at this size unless changed by vote. The initial Board has been formed and appointed, and their names shall appear later in this document. Further information on the manner of election shall be listed in the corporation by-laws.
