**Article I
NAME**

The name of corporation shall be: The Eagle's Nest Covenant Ministries, Inc.

**Article II
PRINCIPAL OFFICE**

The principle place of business and mailing address of this corporation shall be:
1244 Jardin Drive, Naples, County of Collier, Florida 34119

**Article III
PURPOSE**

Said corporation is organized exclusively for religious, charitable and educational activities aimed to establish an international evangelical Christian ministry winning souls for Christ through sponsoring evangelistic crusades, seminars, workshops, conferences, and establishing local churches and mission centers within the United States and abroad, to facilitate the fulfillment of its ministry mandate to gather the hurting, discouraged, and the disillusioned providing faith-based guidance, humanitarian support and resources; and to assist and mentor the gifted and talented members of the Body of Christ, training and equipping them for service as ministers, evangelists and missionaries; and further organized for the fellowship of Christians, regardless of race or national origin, who assemble in regular meetings for worship, praise and study of the holy scriptures; and for such purposes, the organization may receive and make distributions to organizations that qualify as exempt organizations under section 501c3 of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code.

**Article IV
MANNER OF ELECTION OF THE DIRECTORS/OFFICERS**

Directors/Officers of the corporation shall be elected as follows:

The method of electing or appointing the Directors/Officers shall require that the first Board of Directors consist of persons named as the first Directors in the Articles of Incorporation and shall hold office until the first annual meeting of the Board of Directors and until their successors have been elected and qualified. Thereafter, Directors/Officers who shall be elected at annual meetings of the Board of Directors by a plurality of the votes cast, and Directors who are elected in the interim to fill vacancies and newly created directorships, shall hold office until the next annual meeting of the Board of Directors and until their successors have been elected and qualified or until their death, resignation or removal.

In the interim between annual meetings of Directors or special meetings of directors called for the election of Trustees, newly created trusteeships and any vacancies in the Board of Trustees, including vacancies resulting from the removal of Directors for cause, may be filled by the vote of the remaining Directors then in office, although less than a quorum. Terms of all members shall begin immediately upon being seated by the action of the Board. There will be no alternatives to any regular Board member other than elected officials.

Article VIII
ADDITIONAL PROVISIONS

It is decided by the Directors that in the best interest of the Corporation, **The Eagle's Nest Covenant Ministries, Inc.** should elect Internal Revenue Code taxation exemption treatment under Section 501(c)(3). By electing Internal Revenue Code 501(c)(3) the Corporation will be required to use a calendar year with the tax year ending December 31st of each year.

NONDISCRIMINATION NATION POLICY

Notice of non-discriminatory policy as to citizens of the community: **The Eagle's Nest Covenant Ministries, Inc.** of Florida admits citizens of any race, color, national and ethnic origin to all the rights, privileges, programs, and activities generally accorded or made available to recipients in its community outreach, programs and events. It does not discriminate on the basis of race, color, national and ethnic origin in the administration of its charitable policies.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of purposes set forth in the purpose clause hereof.

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the organization shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal Income Tax under section 501(c)(3) of the Internal Revenue Code OF 1986, or corresponding section of any future federal tax code.

ARTICLES OF INCORPORATION

In any taxable year in which the corporation is a private foundation as described in IRC 509(a), the organization shall distribute its income for said period at such time and manner as not to subject it to tax under IRC 4942, and the organization shall not (a) engage in any of self-dealing as defined in IRC 4941(d), retain any excess business holdings as defined in IRC 4943(c), (b) make any investments in such a manner as to subject the organization to tax under IRC 4944, or (c) make any taxable expenditures as defined in IRC 4945(d) or corresponding provisions of any subsequent Federal tax laws.

Article IX
Dissolution of Corporation

The Corporation may be dissolved only upon decision of the Board of Directors.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501c3 of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the County in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.
