NOT FOR PROFIT ARTICLES OF INCORPORATION OF SECHETARY OF STATE FLORIDA

The undersigned natural persons hereby adopt the following Not For Profit Articles of Incorporation for the purpose of forming a not for profit corporation in accordance with the Florida Business Corporation Act.

ARTICLE I - NAME

The name of the not for profit corporation is FL Heartland HOG Chapter Lake Wales, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this not for profit corporation shall be 1501 Longleaf Boulevard, Lake Wales, Florida 33859.

ARTICLE III - PURPOSE

The purpose for which the not for profit corporation is organized is to organize a social motorcycle rider association to facilitate miscellaneous benefit rides and activities.
