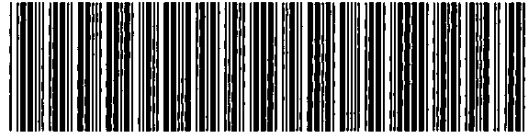



The undersigned natural persons hereby adopt the following Not For Profit Articles of Incorporation for the purpose of forming a not for profit corporation in accordance with the Florida Business Corporation Act.

ARTICLE I - NAME

The name of the not for profit corporation is **FL Heartland HOG Chapter Lake Wales, Inc.**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this not for profit corporation shall be **1501 Longleaf Boulevard, Lake Wales, Florida 33859.**

ARTICLE III - PURPOSE

The purpose for which the not for profit corporation is organized is to organize a social motorcycle rider association to facilitate miscellaneous benefit rides and activities.

Nothing contained in these Articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the not for profit corporation to carry on any business, exercise any power, or do any act which a corporation may not, under Florida laws, lawfully carry on, exercise, or do.

ARTICLE IV - MANNER OF ELECTION

The manner in which the directors are elected or appointed:

All corporate powers, including the election and/or appointment of directors, shall be exercised by or under the authority of, and the business and affairs of this not for profit corporation shall be managed under the direction of, a majority vote of the directors and/or officers of this not for profit corporation. This Article may be amended from time to time by a majority vote of the directors and/or officers of the not for profit corporation.

The directors and/or officers shall have the right to admit new members only by unanimous consent.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a director and/or officer, or the occurrence of any other event that terminates the continued membership of a director and/or officer in the corporation, the remaining directors and/or officers shall have the right to continue the business on unanimous consent of the remaining directors and/or officers.


