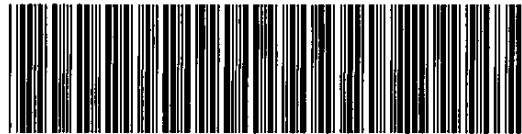

# Article of Incorporation

In compliance with Chapter 617, F.S., (Not for Profit)

## Article 1: Name

The name of the Corporation shall be:

## Article 3: Purpose

The purpose for which this corporation is organized:

The Full Gospel Ministry of Melbourne, Inc. is a not-for-profit corporation committed to serving families in the Great State of Florida through the teaching of educational, moral, social and spiritual values. The Full Gospel Ministry of Melbourne shall be:

- 1) A Christian Church and a Not-For-Profit Corporation.
- 2) A Church that believes in God and Jesus Christ and uses the Bible as its main sources of Christian values and principles.
- 3) A Church that spreads the Christian Faith as stated in Acts 1: 8, Matthew 22:37-39, in accordance with its bylaws and policies as approved by its Management Board.
- 4) A Corporation that respects the laws of the State of Florida and the Counties in general as well as the Divine Law described in the Holy Scriptures.
- 5) A Church that makes God's will while keeping its commandments, as being the fundamental Law of the Jesus Christ Gospel.
- 6) A Church that ministers the word of God to the Faithful (Acts 6:4) to conduct religious worship services through various forms of ministries and to promote and encourage those that are in need through the various ministries of the church (1 Thessalonians 5:11 and James 1:27).
- 7) A church that works with other institutions and corporations to help families (Christians and Non Christians) and to minister the Word of God (1 Corinthians 1:10 and Ephesians 4:4) to spread the Gospel of Jesus Christ by Ministering through the bible studies, fellowships, and other forms of communication (Roman 10:15).
- 8) It shall be a local church (Hebrews 10:25) as well as to implement programs of planting new churches in the State of Florida (Mark 16:15, Acts 1:8-9).
- 9) The Corporation's Pastors will also perform Sacerdotal Functions that include, but not limited to the conduct of regular services, teaching, administration duties, spiritual guidance, baptisms, fellowship communions, weddings, prayer for the sick, home prayer meetings, funerals, and missionary visits. The congregation and its pastors will worship the Lord Jesus Christ on a regular basis at a permanent place and each service will include, worshipping and singing of Hymns.




