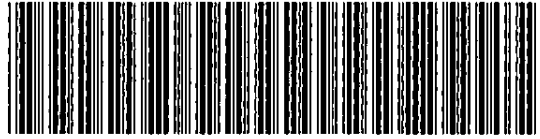

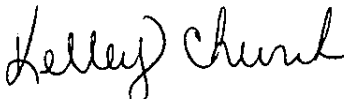

1. Effective as of October 20, 2008, Article I, stating the name of the Corporation, is hereby amended to read in its entirety as follows:
