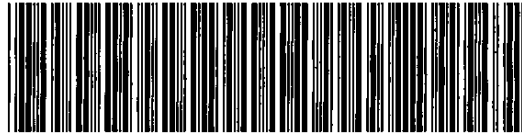

ARTICLES OF INCORPORATION

Articles of Incorporation of Survivor Development Ministry, Inc. The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

ARTICLE I:

The Name of the Corporation shall be Survivor Development Ministry, Inc.

ARTICLE II:

The place in this state where the principal office of the Corporation is to be located is the City of Sarasota, Sarasota County at 330 Midwest Parkway, Sarasota, Florida. The mailing address of the corporation is 330 Midwest Parkway, Sarasota, Florida 34232.

ARTICLE III:

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The corporation will be a support service for survivors of suicide, lending comfort, guidance and assistance after a successful suicide has occurred within the family unit or home. The service will be provided to the surviving client(s) at no cost, and to any person no matter of race, sex, age or religious orientation. The service will be provided through the works of volunteers comprised of former survivors of suicide and from the community at large. There will be no charge to any organization for the service provided to the identified population of suicide survivors.

ARTICLE IV:

The method of appointment or election of the Directors is stated in the bylaws of the corporation.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these article, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for the public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


