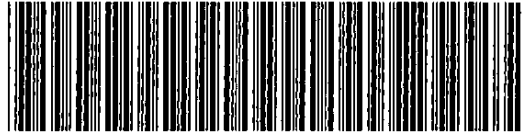

Articles of Incorporation of Walton County Youth Soccer, Inc.

The undersigned, acting as incorporator of a corporation under the Florida General Not for Profit Corporation Act, adopts the following Articles of Incorporation for such Corporation

Article I: Walton County Youth Soccer, Inc.

Article II: 306 Timberline Dr.
Crestview, FL 32539

Article III: Walton County Youth Soccer, Inc. will provide a safe and fun environment to learn and play soccer in Walton County, Florida. The coaches will be parents whom serve as role models for the young kids to provide a positive influence and teach soccer skills and life skills. The program will provide an outlet for any level player and allow anyone wanting to participate in the game of soccer to give it a try. The corporation will include members of the community who will help guide the program and its youth in the proper direction to serve as many civic needs as possible.

The purpose for which this corporation is organized are exclusively charitable, scientific, literary and educational within the meaning of section 501c(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under section 501c(3) of the internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501c(3) of the Internal Revenue Code of 1986 or the corresponding section of any future federal tax law code, or shall be distributed to the federal, state or local government for a public purpose.




