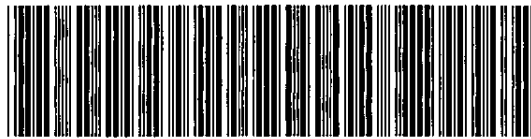

AMENDED ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, desiring to form a Not-for-Profit Corporation under the Laws of the United States and State of Florida, by hereby accept all rights and privileges, benefits and obligations conferred and imposed by said laws and do hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

ARTICLE II

PURPOSE

In conjunction with our mandate to reach the world at all cost, we also the purpose and object of this corporation shall be to act as a social service and referral service organization to assist individuals, particularly the at risk and disadvantaged and other institutions connected therewith of a religious, educational, charitable and benevolent nature, and to establish and engage in charitable, humanitarian and philanthropic activities to the benefit of the underprivileged members of society, creating programs for the chronically at risk. We endeavor to provide for the existence of structured leadership and organizational cohesion by the establishment of community based initiatives via outreach programs, halfway houses and foster homes. To provide a forum where the dynamism of the human spirit may be guided and molded into an effective organism committed through the need for fellowship and mutual support.

ARTICLE III

MEMBERSHIP

Any person willing to accept and abide by the said rules and regulations of the said body as stated in the Constitution and by laws are eligible to become a member of Christ's Bible Church, Inc. In addition they must be willing to disengage themselves in any other religious order that does not believe in the Virgin Birth, Death and Resurrection of our Lord and Savior Jesus Christ. All members in good standing as recorded in the By Laws and Constitution have voting rights and privileges in all matters presented to the general body of the organizations by the Executive Board and or Pastor.

ARTICLE XI

POWERS AND TENURE OF INCORPORATOR

The president/pastor shall be Calvin Levy and he has life tenure of office, successor of its office shall be named by him and in the event of his demise or incapacity to function, the vice president shall at that time assume responsibilities unless otherwise recorded by the president/pastor. The president shall be the authority to sign for and on behalf of all contractual and legal instruments, and has the power to name other such persons. Said corporation is to have the power to do any and all things necessary or expedient for carrying out the said objects and purposes of the corporation and in general possess all rights, privileges and immunities, and enjoy all the benefits granted to non-profits corporations of similar character under the law of the State of Florida and United States.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.

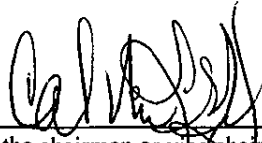
